#### 2022 LEGENDARY WORLD CHAMPIONSHIP TOURNAMENT OFFICIAL RULES

BY ENTERING INTO THE 2022 LEGENDARY WORLD CHAMPIONSHIP TOURNAMENT ("TOURNAMENT"), YOU AGREE TO THESE RULES, WHICH ARE A CONTRACT, SO READ THEM CAREFULLY BEFORE ENTERING THIS TOURNAMENT. THIS TOURNAMENT EXPRESSLY EXCLUDES, RHODE ISLAND AND PUERTO RICO. WITHOUT LIMITATION, THIS CONTRACT INCLUDES INDEMNITIES TO THE UPPER DECK COMPANY ("UDC") FROM YOU AND A LIMITATION OF YOUR RIGHTS AND REMEDIES. ALL ENTRANTS WILL BE REQUIRED TO COMPLETE AND EXECUTE AN ENTRANT AND WINNER RELEASE AND PRIZE ACCEPTANCE AGREEMENT ("RELEASE"). WINNERS WILL ALSO BE REQUIRED TO COMPLETE AND EXECUTE ANY OTHER LEGAL DOCUMENTS WITHIN THE TIMEFRAME REQUIRED BY UDC OR PRIZES MAY BE FORFEITED. ANY TERMS DEFINED IN THE RELEASE SHALL BE THE SAME AS THOSE DEFINED IN THE RULES, UNLESS STATED OTHERWISE.

#### **<u>1. NAME OF TOURNAMENT:</u>**

2022 Legendary World Championship Tournament ("Tournament").

## **2. TOURNAMENT PERIOD:**

The Tournament will be held on August 6, 2022 at Gen Con, a convention held at the Indiana Convention Center located at 100 South Capitol Avenue, Indianapolis, Indiana 46225 ("Tournament Location"). Individual matches for the Tournament will be held on August 6, 2022 beginning at 10:00 am Eastern Time ("ET") and will end at a time determined by the Tournament organizer ("Tournament Organizer"), but no later than midnight ET August 6, 2022 ("Tournament Period").

## 3. ELIGIBILITY:

a. <u>Who May Enter</u>: This Tournament is open and offered only to natural persons who are legal residents of the fifty (50) United States of America ("USA"), including Washington D.C., but excluding Puerto Rico and Rhode Island, who are at least eighteen (18) years old or the age of majority in his/her/their jurisdiction of residence on or before August 6, 2022. Officers, directors, employees, representatives and agents of UDC, its affiliates, UDC's third party licensors including, without limitation, Blizzard, The Overwatch League, National Hockey League Players' Association, National Hockey League Enterprises, L.P. and its related entities, National Hockey League Teams, National Hockey League, Euroleague, Hockey Canada, National Basketball Association, National Basketball Players' Association, Think450, Canadian Football League, Canadian Football League Players' Association, University Of North Carolina, Hockey Hall of Fame, 20th Century, Marvel, Disney, Pressman, Miramax, and All-Elite Wrestling, (collectively "Licensors"), authorized third party distributors, Upper Deck Certified Diamond Dealers, and retailers, and their respective immediate families (i.e., parent, child, sibling or spouse) and/or household members (whether related or not) and any other persons or entities associated with this Tournament are ineligible to enter or win. Void where prohibited by law.

b. <u>Entrant Eligibility:</u> In order to be eligible as an Entrant in the Tournament, all Entrants must completely and fully perform the following to successfully submit his/her/their entry to the Tournament (collectively an "Entry"): (1) pay in full the entry fee at the Tournament Location ; (2) read and agree to the Rules posted at the Tournament Location and on www.upperdeck.com/op, and the Privacy Policy; and (3) complete and submit the Release for the Tournament during the Entry Period.

c. <u>Entry Limitation</u>: Limit one (1) Entry per Entrant; duplicate Entries by an Entrant will be disqualified and removed. All Entries become the exclusive property of UDC and will not be acknowledged, exchanged, modified, or returned. Entries must be received by the Tournament Organizer during the Entry Period to be

considered for the Tournament. Proof of an Entry (such as a copied, printed, or saved version of a "thank you" or confirmation message) does not constitute proof of actual receipt or acceptance of an Entry into this Tournament.

## **<u>4. AGREEMENT TO RULES:</u>**

By participating in the Tournament, Entrants agree to abide by and be bound by these 2022 Legendary World Championship Tournament Official Rules ("Rules") and the decisions of the Tournament Organizer, which are final and binding in all matters relating to the Tournament. Entrant eligiblity for receiving a Participation Prize and/or winning a Cash Prize is contingent upon timely and fulfilling all requirements set forth herein. Furthermore, by submitting an Entry, Entrant agrees that he/she/they will not (a) impersonate any other individual or entity, or otherwise misrepresent his/her/their affiliation with another person or entity, in connection with his/her/their Entry; (b) use any disparaging or derogatory language at the Tournament; or (c) harass, bully, intimidate, or stalk other Entrants at the Tournament.

## 5. HOW TO ENTER:

a. <u>Entry Requirements</u>: An "Entrant" is defined as a natural person who meets the eligibility requirements herein, and submits an Entry during the Entry Period purusuant to these Rules. Beginning on August 5, 2022 at 10:00 am ET and ending at the beginning of the Tournament Period ("Entry Period"), an Entrant must provide the following information on the Release: (1) first name and last name initial; (2) email address; and (3) mailing address.

b. Entry Disqualification: Failure to complete any portion of the Entry or any violation of these Rules will automatically disqualify Entrant from the Tournament. Entries may not be acknowledged and many be destroyed and/or deleted. Entries that are forged, altered, garled will not be accepted and will be void. Neither the Sponsor nor the Tournament Organizer are responsible for late, incomplete, incorrect, delayed, garbled, undelivered, or misdirected Entries. Entries made by any other individual or any entity will be deemed invalid and disqualified for this Tournament. Any attempt made to submit an Entry in excess of the limit herein or otherwise in violation of these Rules by using multiple or false contact information or otherwise may be disqualified. By submitting an Entry, Entrant agrees to follow the rules of the Legendary game and the Upper Deck Official Tournament Policy, both of which are incorporated by reference herein.

# 6. TOURNAMENT PROCEDURE:

a. <u>Overview</u>: The Tournament, including the number of rounds and the bracket as described herein, are based on the number of Entrants who fully participate in the Tournament during the Tournament Period in accordance with the Rules. If, during the Tournament Period, an Entrant leaves and does not return to the Tournament location for any reason after two (2) or more complete and consecutive rounds of play, such Entrant is automatically disqualified from the Tournament and may not re-enter the Tournament. The Tournament Organizer will host the Tournament during the Tournament Period at the Tournament Location. The entire Tournament is a physical event held in person; Entrants may not participate via a proxy or designated representative.

b. <u>Tournament Part One</u>: The Tournament will take place in two (2) parts. The first part of the Tournament ("Part One") is designed as a standard Swiss round style tournament and will consist of a tournament with no less than three (3) and no more than five (5) Entrants at a table in each round. Each round will be limited to fifty (50) total consecutive minutes. The number of rounds is determined by the total number of Entrants participating in the Tournament at the beginning of the Tournament Period. In the first round, Entrants will be randomly matched by Tournament Organizer with their opponents. For all subsequent Part One rounds, Entrants will be matched by Tournament Organizer with their opponents based on the Entrants' standings from the immediately preceding round. During each round, Entrants will play one (1) game subject to the Legendary game rules that are included with purchase of any Legendary game, whereby Entrants will aim collect Victory Points

by defeating the Mastermind and/or Villains and rescuing Bystanders. At the end of the round, determined either by the game completing the scheme or time expiring, Victory points are calculated. At the end of each round, the Entrant with the most Victory Points receives five (5) Round Points, the Entrant with the second most Victory Points receives three (3) Round Points, and the Entrant with the third most Victory points receives one (1) Round Point. The remaining Entrants in the round will not receive Round Points for that round. If the Entrants are tied, then End of Round procedures should be followed in line with the Upper Deck Tournament Policy, which is incorporated by reference herein and shall be read out loud by the Tournament Organizer at the start of the Tournament as well as posted by the Tournament Organizer at the Tournament Location for the duration of the Tournament Period. The Tournament Policy is also posted online at www.upperdeck.com/op. Entrants' Round Points standings shall be updated by the Tournament Organizer at the conclusion of each round. After each round, Entrants will be matched by the Tournament Organizer with different opponents based on the Tournament standings at the end of the round and assigned a new "table" during each subsequent round, if applicable. After a Tournament Organizer-determined number of rounds based on the number of Entrants, Entrants with the highest total Round Points ("Top Cut") will be eligible to move on to the second part of the Tournament ("Part Two"). Top Cut is determined by the total number of Entrants at the beginning of the Tournament Period. The Top Cut determines the second part of the Tournament.

c. <u>Tournament Part Two</u>: Part Two is a single elimination bracket style tournament with no less than three (3) and no more than five(5) Entrants assigned to a table. Entrants will be matched by Tournament Organizer into a tournament bracket with their opponents based on the final standings at the end of the Swiss round in Part One. Rounds in Part Two are limited to fifty (50) total minutes in time, unless determined by the Tournament Organizer in his/her/their sole discretion based on the Tournament Location's business hours. During each round in Part Two, Entrants collect Victory Points by defeating the Mastermind and/or Villains and rescuing Bystanders pursuant to the Legendary game rules. At the end of the round, determined by either the completion of the game scheme or time expiration, the Tournament Organizer shall calculate Victory Points and the Entrant(s) with the most Victory Points are declared the winner(s). Losers of each round will be eliminated from the remainder of the Tournament. The winners from each round of Part Two will advance to the next round until the final four (4) remaining Entrants are matched by Tournament Organizer (collectively the "Finalists"). The Finalists will play one game to determine the overall winner of the Tournament. The Finalists with the best win/loss record at the end of the final round at the end of Part Two will be determined the winners ("Winners"). The Finalist with the most Victory Points at the end of the final round at the end of the first place Winner.

d. <u>Tournament Organizer</u>: The Tournament Organizer will (i) manage Tournament registration; (ii) confirm all information and documentation is properly completed by each Entrant and that each Entrant is eligible to participate in the Tournament based on the requirements herein and any other requirements identified by the Tournament Organizer prior to the Tournament Period; (iii) set up Tournament pairings for each Tournament round; (iv) provide the results of each round to the Entrants; (v) answer any Entrant questions throughout the Tournament; (vi) enforce these Rules and the Tournament Location rules; (vii) organize judges for the Tournament; and (viii) disseminate the Participation Prize to each player at the beginning of the Tournament.

#### 7. SELECTING WINNERS:

On August 6, 2022, the Tournament Organizer will announce the Winners at the conclusion of Tournament Period. Entrants will be ranked based on his/her/their Round Points during the Tournament, which is determined by Entrant's opponents' total (i) Round Points; and (ii) total Victory Points. Within three (3) weeks of the Tournament's conclusion, UDC will announce the ranking of all Entrants who participated in the Tournament ("Ranking List") on UDC's blog located at upperdeckblog.com ("Blog"), and UDC's social media channels: Facebook: @UpperDeckEnt, Instagram: @UpperDeckEnt, Twitter: @UpperDeckEnt, YouTube: @UpperDeck, Discord: https://discord.gg/sYpwD9sq8T (together, the "Platforms"). Entrants who were removed from the Tournament for any reason will be listed as "dropped" on the Ranking List.

Each Winner will each receive a percentage of the Five Thousand Dollar (U.S.D. \$5,000.00) cash prize ("Cash Prize"), as further described herein, subject to and based on the number of Entrants who participated in the Tournament.

#### 8. PRIZES:

a. <u>Prizes Available:</u> All Entrants who complete the Entry requirements herein will receive one (1) promotional Legendary card (the "Participation Prize") for his/her/their participation in the Tournament. The value of the Participation Prize varies based on the secondary market and other factors, and UDC makes no representation or warranty as to the value of the Participation Prize. The total Cash Prize available is valued at Five Thousand Dollars (U.S.D. \$5,000.00).

i. In the event there are between four (4) and seven (7) Entrants in the Tournament, the Cash Prize will be distributed as follows: the first place Winner will receive a Cash Prize of Three Thousand Dollars (U.S.D. \$3,000.00) and the second place Winner will receive a Cash Prize of Two Thousand Dollars (U.S.D. \$2,000.00). The remaining Entrants will not receive a Cash Prize.

ii. The remaining Entrants will not receive a Cash Prize.

iii. In the event there are between thirty two (32) and sixty three (63) Entrants in the tournament the Cash Prize will be distributed as follows: the first place Winner will receive a Cash Prize of Two Thousand Dollars (U.S.D. \$2,000.00), the second place Winner will receive a Cash Prize of Nine Hundred Dollars (U.S.D. \$900.00), the third place Winner will receive a Cash Prize of Five Hundred Dollars (U.S.D. \$500.00), the fourth place Winner will receive a Cash Prize of Five Hundred Dollars (U.S.D. \$500.00), the fourth place Winner will receive a Cash Prize of Five Hundred Dollars (U.S.D. \$500.00), the fifth place Winner will receive a Cash Prize of Two Hundred Dollars (U.S.D. \$200.00), the sixth place Winner will receive a Cash Prize of Two Hundred Dollars (U.S.D. \$200.00), the seventh place Winner will receive a Cash Prize of Two Hundred Dollars (U.S.D. \$200.00), the sixth place Winner will receive a Cash Prize of Two Hundred Dollars (U.S.D. \$200.00), the sixth place Winner will receive a Cash Prize of Two Hundred Dollars (U.S.D. \$200.00), the seventh place Winner will receive a Cash Prize of Two Hundred Dollars (U.S.D. \$200.00), the sixth place Winner will receive a Cash Prize of Two Hundred Dollars (U.S.D. \$200.00), the eighth place Winner will receive a Cash Prize of Two Hundred Dollars (U.S.D. \$200.00), the ninth place Winner will receive a Cash Prize of Two Hundred Dollars (U.S.D. \$200.00), the ninth place Winner will receive a Cash Prize of Two Hundred Dollars (U.S.D. \$125.00), and the tenth through sixteenth place Winners will each receive a Cash Prize of Twenty Five Dollars (U.S.D. \$25.00). iv. In the event there are sixty four (64) or more Entrants in the tournament the Cash Prize will be distributed as follows: the first place Winner will receive a Cash Prize of One Thousand Five Hundred

Dollars (U.S.D. \$1,500.00), the second place Winner will receive a Cash Prize of Seven Hundred Dollars (U.S.D. \$700.00), the third place Winner will receive a Cash Prize of Four Hundred Fifty Dollars (U.S.D. \$450.00), the fourth place Winner will receive a Cash Prize of Four Hundred Fifty Dollars (U.S.D. \$450.00), the fifth place Winner will receive a Cash Prize of Two Hundred Fifty Dollars (U.S.D. \$250.00), the sixth place Winner will receive a Cash Prize of Two Hundred Fifty Dollars (U.S.D. \$250.00), the sixth place Winner will receive a Cash Prize of Two Hundred Fifty Dollars (U.S.D. \$250.00), the signth place Winner will receive a Cash Prize of Two Hundred Fifty Dollars (U.S.D. \$250.00), the seventh place Winner will receive a Cash Prize of Two Hundred Fifty Dollars (U.S.D. \$250.00), the eighth place Winner will receive a Cash Prize of Two Hundred Fifty Dollars (U.S.D. \$250.00), the ninth place Winner will receive a Cash Prize of One Hundred Fifty Dollars (U.S.D. \$250.00), and the tenth through sixteenth place Winners will each receive a Cash Prize of Seventy Five Dollars (U.S.D. \$75.00), and the seventeenth through twenty fifth place Winners will each receive a Cash Prize of Twenty Five Dollars (U.S.D. \$25.00). The remaining Entrants will not receive a Cash Prize.

In the event there are only three (3) Finalists, the Tournament Organizer shall, in his/her/their sole discretion, divide the total Cash Prize among the first place Winner and second place Winner. In the event there are only two (2) Finalists, the Tournament Organizer maintains the sole discretion to award the total Case Prize to the first place Winner. In the event there is only one (1) Finalist, the Tournament Organizer maintains the sole discretion to award the total Cash Prize to the first place Winner. Only Winners will receive the Cash Prize.

b. <u>Prize Eligibility</u>: In order to receive the Participation Prize and/or Cash Prize, all Entrants must timely (1) read and agree to these Rules and the Privacy Policy by submitting an Entry; and (2) execute the Release. In addition to the foregoing, the Winners must also execute and return to UDC a W9 tax form as defined herein.

c. <u>Receiving the Prize</u>: Eligible Entrants will each receive the Participation Prize at the beginning of the Part One of the Tournament. Within five (5) business days after the end of the Tournament Period, UDC will email all Winners using the email address provided by the Winner in his/her/their Release ("Winner Notification") requesting each Winner execute and return a W-9 tax form, if not provided by the Entrant at the time of the Entry. Winners must execute and return the W9 tax form within five (5) business days of receiving the Winner Notification in order to receive the Cash Prize. Within thirty (30) calendar days of UDC's receipt of Winner's completed W9 tax form, UDC will mail Winner a check for the applicable Cash Prize based on information provided by Winner in the Release. The Cash Prize will be mailed via first class U.S. mail, to the mailing address provided by Winner in the W9 tax form and made payable in Winner's name.

d. Prize Disclaimers: By participating in the Tournament, Entrant acknowledges and agrees UDC is not responsible to replace any Participation or Cash Prizes. UDC will not replace any lost, damaged, stolen, or undeliverable Participation Prize and, if applicable, the Cash Prize that do not reach Winners because of an incorrect or modified address or other contact information. If the Winners do not accept the entire Participation Prize and, if applicable, timely deposit the Cash Prize, the unaccepted Participation Prize and, if applicable, the Cash Prize will be forfeited and UDC will have no further obligation with respect to that Participation Prize and, if applicable, the Cash Prize, or to the Entrants or the Winners. UDC is not responsible for any inability of any Entrant or Winner to accept, use, or deposit any Participation Prize and, if applicable, the Cash Prize, (or portion thereof) for any reason. No Participation Prize and, if applicable, the Cash Prize, substitutions or other consideration will be provided to an Entrant or the Winners, except in UDC's sole discretion. UDC reserves the right and sole discretion to substitute the Participation Prize and, if applicable, the Cash Prize, or any portion thereof of for a similar value of the Participation Prize and, if applicable, the Cash Prize, for any reason, including, without limitation, Participation Prize and, if applicable, the Cash Prize, unavailability. No amount greater than the stated Participation Prize and, if applicable, the Cash Prize, will be awarded. Any federal, state and local taxes, as well as any expenses costs, travel costs or any other fees not specifically listed in these Rules as being provided as part of the Participation Prize and, if applicable, the Cash Prize, are the Entrant's sole

responsibility. The Tournament is entirely a game of skill and an Entrant's likelihood of winning a Cash Prize, is determined based on the Entrant's skill-based performance in each part of the Tournament.

The Participation Prize and, if applicable, the Cash Prize, cannot be purchased and/or obtained in any way outside of the Tournament, and cannot be refunded, exchanged, replaced, or redeemed for any non-virtual items of any kind. Entrants are solely responsible for all matters relating to or arising from the Participation Prize and, if applicable, the Cash Prize, after it is awarded. If (i) the Cash Prize, or related notification is returned as unclaimed or undeliverable to a Winner, and such Winner cannot be reached via email three (3) business days from the date of the Winner Notification; (ii) the Winners fail to return requisite document(s) provided by UDC following the Winner Notification, and within the specified time period; or (iii) if a Winner does not fully comply with these Rules, then such Winner shall be disqualified and, in UDC's sole discretion, an alternate Winner may be selected.

## 9. PRIZE CONDITIONS:

a. Prize Release: By accepting the Participation Prize and, if applicable, the Cash Prize, each Entrant agrees to forever release and hold harmless UDC, the Tournament Organizer, and the Released Parties from and against any and all claims, demands, losses, liabilities, damages, costs, or causes of action arising out of or related to participation in the Tournament, Entry, or receipt or use of the Participation Prize and, if applicable, the Cash Prize. Further, by accepting the Participation Prize and, if applicable, the Cash Prize, each Entrant grants to UDC an irrevocable, perpetual, worldwide, sub-licensable, royalty-free license to feature the Entrants' name, image and likeness (collectively the "Attributes"). Each Entrant agrees to indemnify, defend, and hold harmless UDC, its licensors, and their respective officers, directors, employees, and agents from any and all damages, costs, liabilities, claims, disbursements, actions, and expenses, including without limitation, attorneys' fees, arising out of or related to the Attributes. Entrants will not enter into any settlements or make any admissions on UDC's behalf without UDC's prior written consent. Entrants acknowledge and agree that his/her/their participation in the Tournament, eligibility to receive, and/or receipt of a Participation Prize and, if applicable, the Cash Prize, is contingent upon his/her/their full compliance with the Rules and conditions herein and is good, valuable, and sufficient consideration to participate in the Tournament, and to receive a Participation Prize, and, if applicable, the Cash Prize. The Participation Prize and, if applicable, the Cash Prize, are subject to prior verification of eligibility, as well as compliance with these Rules. The Participation Prize and, if applicable, the Cash Prize, may not be transferred or assigned. If legitimately claimed, the Participation Prize and, if applicable, the Cash Prize will be awarded. Entrants acknowledge and agree this Tournament is not sponsored or endorsed by UDC.

Entrants hereby grant to UDC and its affiliates, related parties the irrevocable, perpetual license and right to print, publish, disseminate, broadcast and use worldwide IN ALL MEDIA without limitation at any time the Entrants' name, image and likeness for advertising, trade and promotional purposes without further payment or additional consideration, and without review, approval or notification.

b. <u>Tax Implications:</u> Winners who are residents of the U.S.A. must note that the value of the Cash Prize is taxable as income and an I.R.S. Form 1099 ("1099") will be filed in each Winner's name for the estimated value of the Cash Prize. UDC may request additional information from Winners to submit the 1099 and Winners must provide such information within five (5) business days from UDC's request thereof in order to receive the Cash Prize.

## **10. LICENSE GRANTED:**

By entering into this Tournament, all Entrants agree to these Rules including, without limitation, this Section 10. Discord, in addition to their websites and blogs and for advertising and promotional purposes without additional consideration or notice to Entrant in all manners and media unless prohibited by law. ## **<u>11. INDEMNIFICATION:</u>**

Entrant agrees to indemnify, defend, and hold harmless the Released Parties against any and all claims, liabilities, suits, losses, damages, and expenses (including, without limitation, attorneys' fees) arising out of or related to the Tournament, Rules, the Participation Prize, Entry, and, if applicable, the Cash Prize. FAILURE BY UDC TO ENFORCE ANY PROVISION OF THESE RULES SHALL NOT CONSTITUTE A WAIVER OF THAT PROVISION OR ANY LEGAL OR EQUITABLE RIGHTS.

# 14. RELEASE AND LIMITATION OF LIABILITY:

WITHOUT LIMITING THE GENERALITY OF THE FOREGOING, THE RELEASED PARTIES DO NOT MAKE ANY EXPRESS OR IMPLIED WARRANTIES OR REPRESENTATIONS WITH RESPECT TO THE TOURNAMENT OR THE PARTICIPATION PRIZE AND, IF APPLICABLE, THE CASH PRIZE, AND UDC IS NOT LIABLE FOR THE CONSEQUENCE OF ANY INTERRUPTIONS OR ERRORS RELATED THERETO. SOME JURISDICTIONS DO NOT ALLOW THE EXCLUSION OR LIMITATION OF CERTAIN TYPES OF DAMAGES, THEREFORE SUCH EXCLUSIONS MAY NOT APPLY TO YOU.

## **15. NAME AND LIKENESS RELEASE:**
